### **2015 Fall Commission Meeting**

On October 20<sup>th</sup> the Planning Commission held its 2015 Fall Commission Meeting at The Inn at East Hill Farm in Troy, NH. ### **Swanzy Adopts Complete Streets Policy**

During October the Town of Swanzy adopted a complete streets policy making it the fourth community in New Hampshire to do so. Other New Hampshire communities that have adopted similar policies include Portsmouth, Concord, and Dover. The policy, which was adopted by the Selectboard on October 13<sup>th</sup> directs the Town to consider the safety of all users - including motorists, pedestrians of all ages and abilities, bicyclists, emergency responders, freight providers, and users of public transit - in all municipally managed transportation projects and project phases. The policy was developed by a complete streets committee comprised of Town staff, planning board members, community members, and SWRPC staff. ### **Proposed Paving Schedule on State Highways**

As part of the NH Department of Transportation's recent draft release of the Ten Year Plan, it has developed a proposed pavement resurfacing program for state highways from 2015 through 2018. The newly released information includes statewide maps showing project locations with map legends indicating the type of treatments planned for each project. Also included are additional descriptions explaining project start and end points as well as mileage. ### **Road Surface Management System Pilot**

In most municipalities, road surfaces are the largest single cost of maintaining and building a transportation system. Forty to fifty percent of public funds spent on roadway systems are for the road surface. A road surface management system (RSMS) can assist municipalities by organizing condition data and repair strategies all in one place, making it easier to make cost-effective decisions about roadway maintenance. The Planning Commission is currently working with NH DOT, the University of New Hampshire Technology Transfer Center, and the Town of Dublin to pilot an updated RSMS. SWRPC has begun collecting roadway surface data which will continue into the Fall. Other aspects of the pilot include condition forecasting, scenario planning based on pavement maintenance strategies, and a cost and benefits analysis. Following completion of the pilot, the Planning Commission anticipates offering the RSMS service to other interested communities. ### **NH Wildlife Action Plan**



Emily Preston, Wildlife Biologist for the NH Fish and Game Department will present the Plan which contains the most up-to-date research on NH's wildlife features, including summaries of actions that can be taken to help mitigate pressures that have negative impacts on NH's wildlife and habitats. ## Community Development Block Grant Funding

For towns and organizations thinking about applying for the January 2016 round of Community Development Block Grant (CDBG) funding, now is a good time to start the application process. Housing and public facilities CDBG funding is available to municipally-sponsored projects in January and July of each year. Eligible projects can receive grants of up to \$500,000 for infrastructure or housing projects with a direct benefit to low and moderate income individuals and families. CDBG funding is also available for municipally-sponsored economic development projects year-round on a first come, first served basis starting in January. Up to \$500,000 is available for economic development projects that help create job opportunities for low to moderate income individuals and families.
